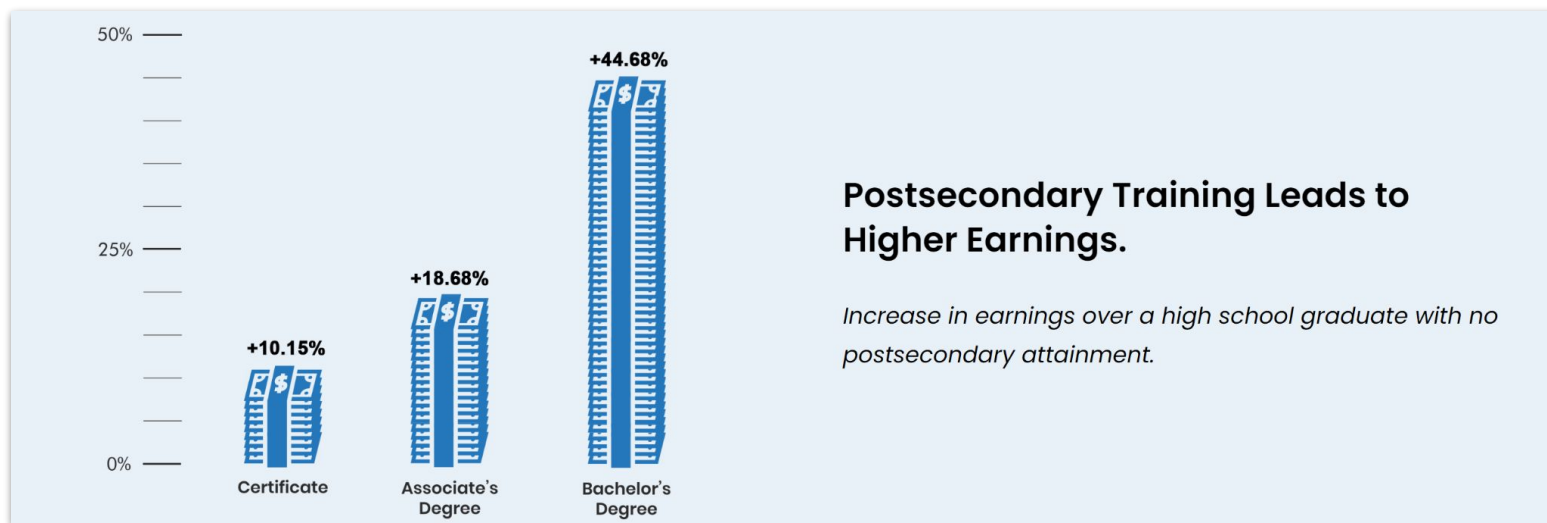

ELEMENT 3B: POSTSECONDARY DEVELOPMENT - Effective school counselors work within a **cradle to career** support system. In a scope and sequence frame, they educate students at all grade levels and prepare students to access various **postsecondary options** and provide comprehensive information regarding **career pathways** and **financial aid** to support **informed decision making**. Additionally, they educate students and caregivers on the sequential steps needed to prepare for **admission into postsecondary institutions** and **workforce opportunities**.



The Impact of Postsecondary Education

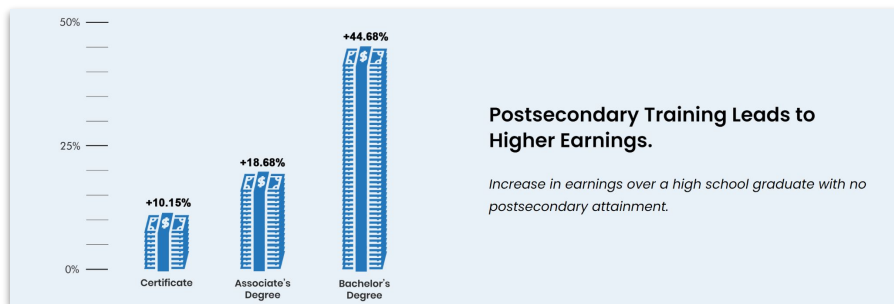
Research shows that postsecondary education is strongly correlated to higher lifetime earning:



Differential Access & Outcomes

According to the Higher Education and Economic Opportunity in California report:

- ▶ Students from higher-income backgrounds are more than twice as likely to earn a bachelor's degree than their lower-income peers.
- ▶ The vast majority of low-income Latinx and African-American students never attend a 4-year college.

CCGI: Our Three Big Goals

CaliforniaColleges.edu is a 6th-12th grade college and career guidance platform and data infrastructure which can be used to close equity gaps by:

- 1. Systematizing college and career knowledge development** and access to high quality information for all 6-12th public school students.
- 2. Streamlining the college and financial aid application process** for students and the educators supporting them.
- 3. Providing educators with the data they need** to monitor student progress and provide targeted interventions to move the needle on college and career readiness, eligibility, and application and enrollment rates.

Accounts for All Students

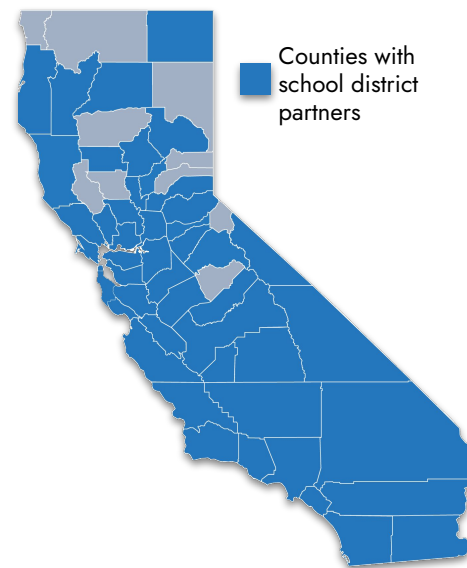
All 6-12th grade public school students have accounts on CaliforniaColleges.edu.

- ▶ In 2021, with the enactment of AB 132, CaliforniaColleges.edu tools and services were made free to all California school districts serving 6-12th grade students.
- ▶ Beginning in Fall 2024, a data-sharing agreement between CCGI and the California Department of Education (CDE) leverages Calpads to create Basic Accounts so that all students have access to the baseline college, career, and financial aid knowledge development tools of CaliforniaColleges.edu.
- ▶ [California Education Code 60900\(f\)\(3\)](#) now **requires that all LEAs** that enroll 9-12 grade students **enter into a data sharing agreement with CCGI by January 2026** in order to bring Transcript-Informed Accounts to students.

Transcript-Informed Accounts

Partner Districts have a formal data-sharing agreement (MOU) with CCGI in order to bring their high school transcript data to CaliforniaColleges.edu.

- ▶ More than **70% of California's public high school** students are enrolled in a school district that has partnered with CCGI.
- ▶ Our Partner Districts include more than **300 school districts** that serve more than **1.3 million 9th-12th grade students** in California public schools.

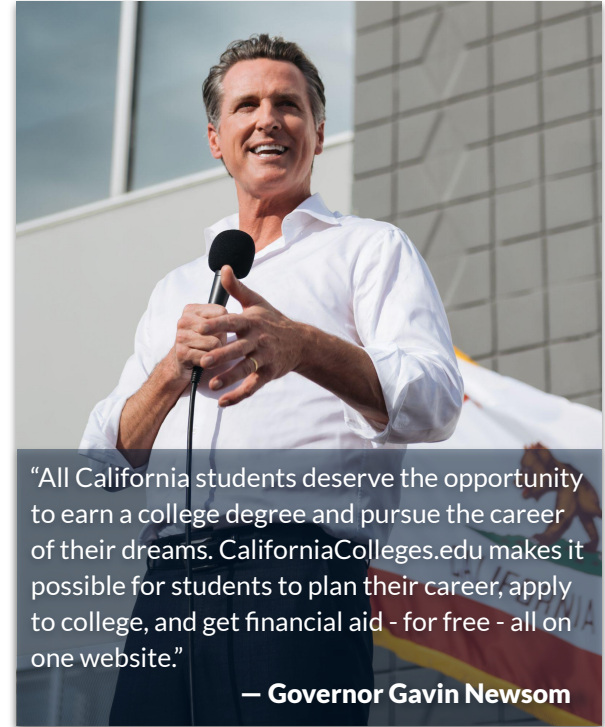

Why has California Invested in a Common Platform?

Key Facts:

- ▶ **80%** of K-12 students in California **stay in-state** for training and education after high school.
- ▶ **56%** of high school seniors **did not meet A-G** requirements for CSU or UC admission in 2023.
- ▶ **\$493,000,000** is the estimated amount of federal Pell Grant dollars unclaimed by California graduates in 2023.
- ▶ Students have to navigate **California-specific processes** and therefore need **California-centric tools and resources**.
- ▶ **Districts** likewise need **tools to support implementation** of policies and investments aimed at **increasing student success**.

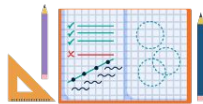

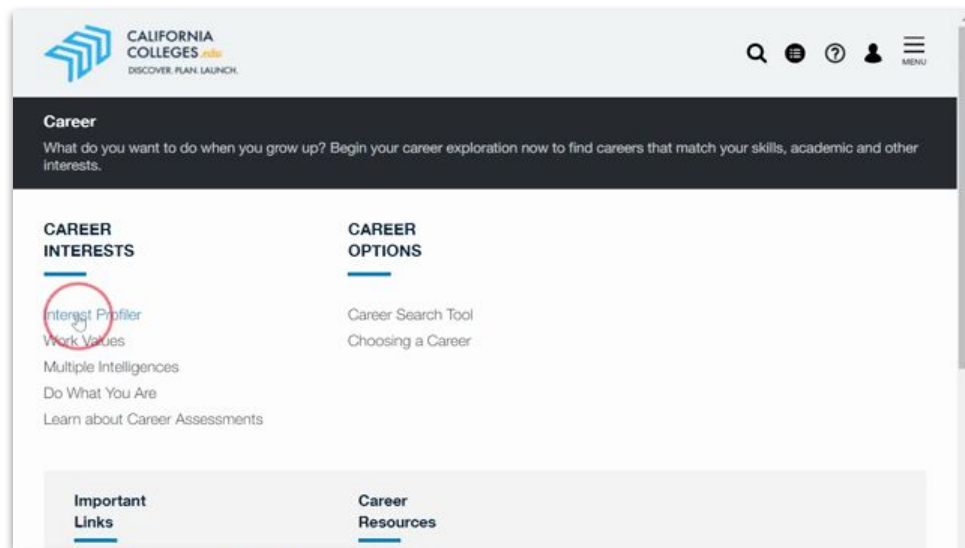
Reporting Tools to Inform Student Support

Career Exploration

The Career Search Tool helps students find the right career path by figuring out what they want to be and what it will take for them to get there.

CaliforniaColleges.edu allows students to:

- ▶ Tie career assessment results to career pathways, majors, and colleges.
- ▶ Understand what education and skills they will need to pursue their career of choice.



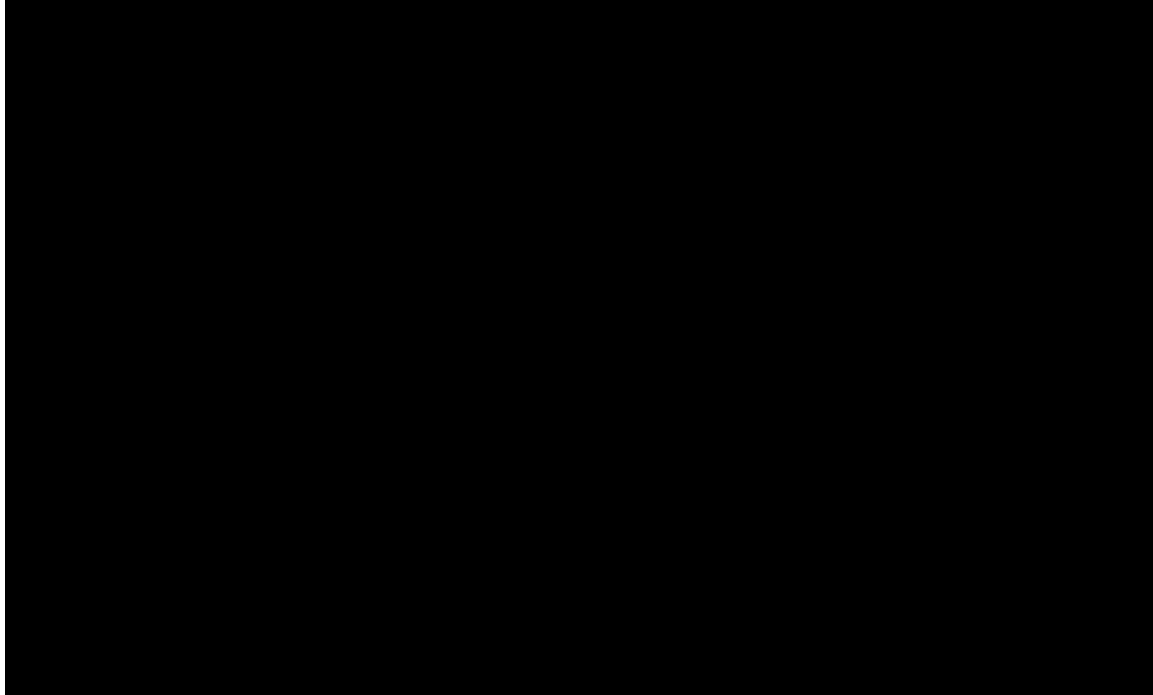

- **Completed:** These students have launched their FAFSA/CADAA from [CaliforniaColleges.edu](#) and CSAC confirms the application is complete. A completed application has a calculated Student Aid Index (SAI) and can be used to determine Cal Grant eligibility if the GPA is matched.

Districts/LEAs that serve high school students partner with CCGI to provide students and educators with the full suite of tools and supports available on the platform:

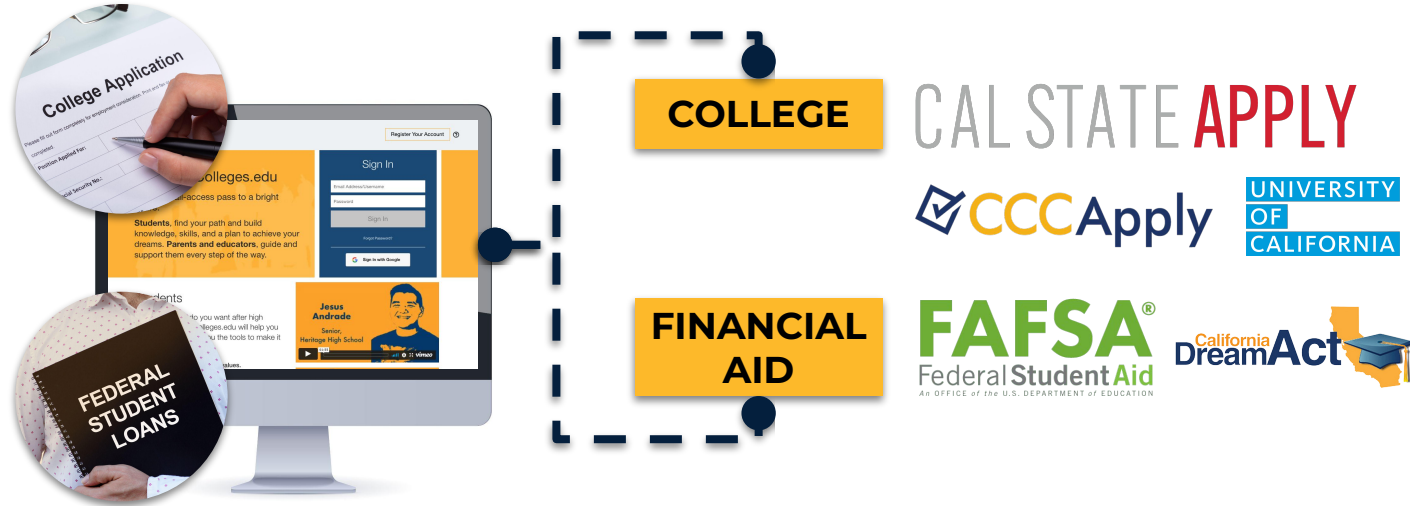
- ▶ **Transcript-Informed Accounts for students,** which include:
 - **California Community Colleges (CCC) Tool** which helps students to identify the five CCCs closest to their high school and to learn more about program options.
 - **CSU and UC Eligibility Tools** that allow students to see their progress towards meeting the minimum requirements for admission to a CSU and UC.
 - The ability to **import verified transcript data** to their Cal State Apply Application and UC Application.
- ▶ **A-G Alignment Support** for districts to ensure that students get correct A-G credit for high school courses and grades in their college applications.
- ▶ **Enhanced Educator Reporting** to support ongoing progress monitoring and intervention.

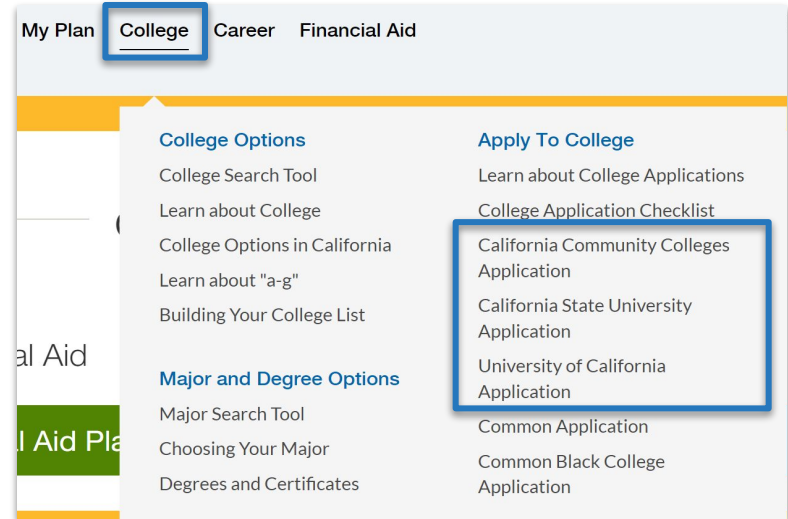

There are lots of great reasons to attend a California Community College (CCC). A CCC may be the best fit for you if:

- You need an **associate degree or certificate** for the career you want.
- You want to **start your career sooner**. Associate degree programs usually take two years. Certificate programs take even less time.
- You want to **prepare to transfer** to a four-year college.
- You want to **spend less money** on college tuition. CCCs have the lowest fees in the nation.
- You want to **stay close to home**. With 115 campuses across California, there is probably a CCC close to you.
- You need **flexible classes** in the evening, on weekends, or online so you can fit college into your life.
- You want to **get a head start on earning college credit** while you're still in high school.

Requirements

To attend a CCC, all you have to do is fill out an application and pay any required fees. You don't have to complete A-G requirements or take any special classes.

Transfer Options

You can start at a CCC and transfer to a CSU, UC, or independent college after two years. Complete one of the programs below at your CCC to secure your spot.

- The [Transfer Admission Guarantee \(TAG\)](#) program guarantees you a spot at one of six UCs.

A-G Alignment Support

CCGI provides technical assistance to help LEAs ensure that courses indicated as fulfilling A-G requirements match the Course Management Portal.

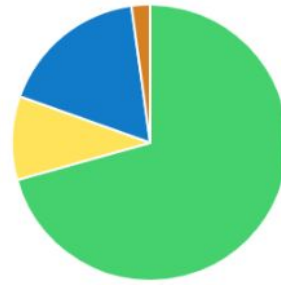
- ▶ California Education Code 60900(g) requires that LEAs maintain at least a 90% rate of alignment between A-G coursework, as listed in the local SIS, and how those courses are registered in the UC Course Management Portal A-G course list.
- ▶ CCGI has a dedicated Technical Assistance team to support districts in improving their CMP match rate.
- ▶ CaliforniaColleges.edu reporting features help educators identify and resolve issues with their CMP list that may impact eligibility for students:
 - Academic Report: **Which district courses are flagged as A-G but do not match against the CMP?**

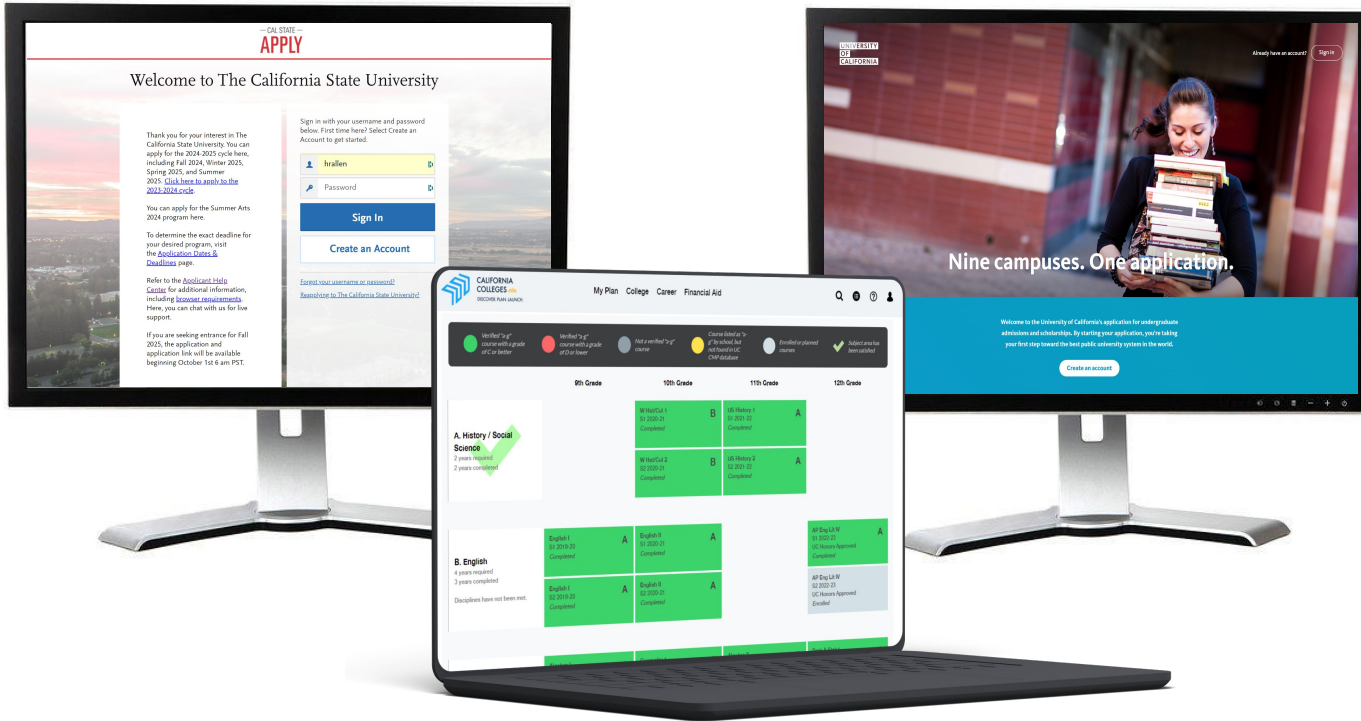

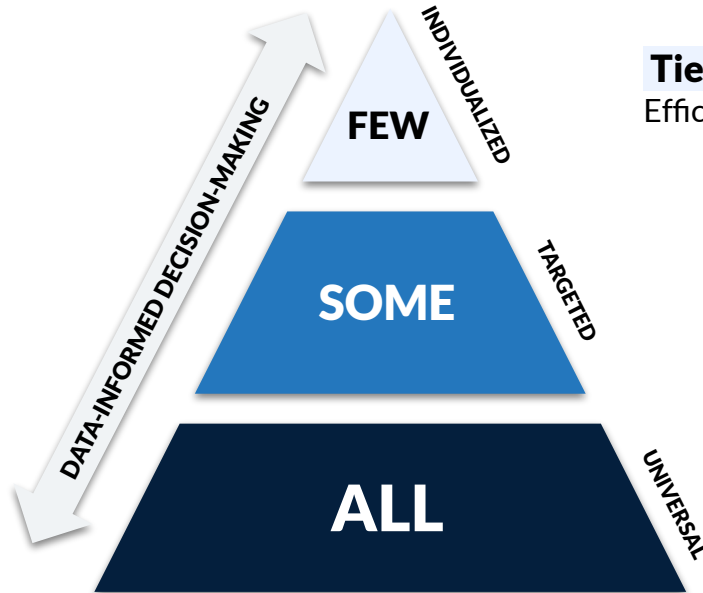

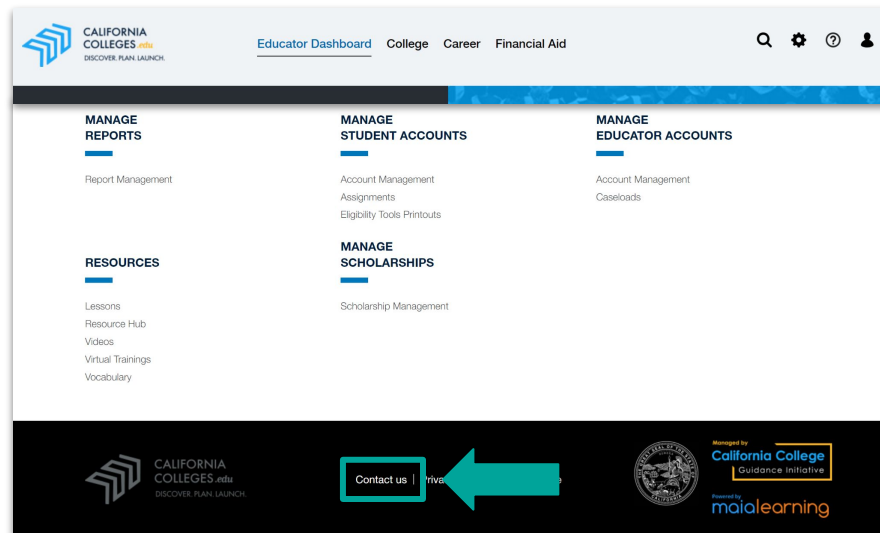
