# **Three Big Objectives**

CCGI manages CaliforniaColleges.edu, the State of California's official college and career planning platform for 6th-12th grade students enrolled in public schools. CaliforniaColleges.edu can be used to close equity gaps by:

- Systematizing college and career knowledge development for 6th-12th grade students.
- 2. Streamlining the college and financial aid application process for students and the educators supporting them.
- 3. Providing educators with the data they need to:
  - Maximize course placement during high school.
  - Inform high stakes decisions about admissions, placement, advising, financial aid and supportive services as students transition to college.



# CaliforniaColleges.edu Overview

CaliforniaColleges.edu is the State of California's official college and career planning platform.

We provide <u>students</u> with:



- Career Exploration Tools
- College and Major Search Tools
- College, Career and Financial Aid Lessons
- CSU and UC Eligibility Tools
- College and financial aid application integrations

We provide <u>educators</u> with:




- College and career planning tools in one place

# What is CA Education Code § 60900.5?

In 2021, AB 132 was enacted, including EDC § 60900.5, which charged CCGI with:

*******	
1	Ensuring all 6th-12th grade students have accounts on CaliforniaColleges.edu.
2	Providing final transcripts to the public higher education systems and transcript level data to the California Student Aid Commission (CSAC).
3	Pre-populating applications to the California Community Colleges (CCC), California State University (CSU), and University of California (UC) systems with students' courses, grades, and demographic information.
4	Developing college, career, and financial aid lessons and tools that facilitate college and career planning for students, families, and the educators serving them.



# **SB 153: Summary of Changes**

# California State Education Code was updated in Summer 2024 with the following:



All districts serving 9th-12th grade students must **provide "transcript-informed" accounts to their students**; requires LEAs to **enter data-sharing agreement with CCGI** by January 1, 2026 with those transcript-informed accounts live by June 30, 2026.



To support LEAs, requires **School Information System (SIS) vendors to comply with the Standard and Spec** and build an API, without passing any associated costs onto LEAs.



Using reports and technical assistance from CCGI, districts must **maintain 90% alignment of A-G coursework** with the **UC Course Management Portal (CMP)** .



California School Information Services (CSIS) will **notate SIS providers' compliance with the Standard and Spec** and the format in which they can pass data to CCGI.



# California High School Transcript and Student Record Portability Standard

# Cal. Ed. Code § 60900.5 requires CCGI to provide:

(8)Transcripts processed in near real time with the California Community Colleges, the California State University, the University of California, and the Student Aid Commission, using an application programming interface.

To facilitate the work, CCGI developed the **California High School Transcript and Student Record Portability Standard** and its associated **Data Specification**.

They are housed in the Cradle to Career Data System's Data Standards Repository:



# What are the "Standard" and "Spec"?

# **Standard**

- Provides guidance for California public high school transcripts.
- Details the required and optional data elements for Student Record Portability.
- Elements include, but are not limited to, those which would be contained in a traditional paper transcript.
- Intended for electronic data exchange.

# **Spec**

- A supplement to the Standard.
- Contains the data elements that California public unified and high school districts in partnership with CCGI should submit to:
  - Create accounts on CaliforniaColleges.edu.
  - Support application integrations with the state's public higher education systems.
  - Inform transcripts provisioned according to the Standard.



# Leveraging the Capacity of Student Information System (SIS) Vendors

- EDC § 49083.5 requires SIS vendors to incorporate the data elements included in the the Standard and Spec and share that data to CCGI without passing any associated costs onto the LEAs.
  - Each SIS vendor is required to host an API to transmit the elements in the Spec to CCGI.
- California School Information Services (CSIS) will publish SIS vendors' compliance.

# **API** Design

# **Detailed Requirements Documentation**

- Available for vendors when they are ready to begin technical development
- OpenAPI Specification 3.1.0 in SwaggerHub
- REST architectural design mapped to endpoints to obtain data representing data in the Standard
- Pull API using a JSON Web Token
  - GitHub repository available for vendor use in API endpoint validation
- Authentication and Authorization through OAuth2.0 client credentials via confidential application, encoded credential transfer and scoped JWT per LEA
  - Highly secure and enables LEAs to retain control of their data
  - SIS Vendors will facilitate LEAs granting permission to CCGI to access data and provide transformation configuration features

# SB 153: Updates Related to CCGI

In Summer 2024, California Governor Gavin Newsom signed SB 153, which enacted several updates to the California Education Code related to CCGI's

## Pre-populating applications to the CCC, CSU, and UC systems with students' courses, grades, and demographic information.

Establishes CaliforniaColleges.edu as the future state infrastructure through which CCC must provide CCGI with college courses and grades completed by high school students for integration into a "unified high school transcript" (electronic). # K-12 SIS Vendor Cal. Ed. Code Notification

For those Serving Local Educational Agencies with California Public 9-12th Grade Students



October 2024

#### **Notification of New California Education Code**

In summer 2024, <u>SB 153</u> updated <u>EDC § 60900(f)(3)</u> to require all California public local educational agencies (LEAs) serving 9th-12th grade students enter into a data sharing partnership with the California College Guidance Initiative (CCGI), and <u>EDC § 49083.5</u> to direct California School Information Services (CSIS) to publish K-12 SIS providers' compliance with the <u>California High School Transcript and Student Record Portability Standard</u> ("the Standard") and its associated <u>Data Specification</u> ("the Spec") and the format in which they can pass data to CCGI. The Spec is intended for electronic data transmission via an API established between K12 SIS vendors and CCGI. Alternatively, <u>Data Element Templates</u>, which outline how data may be submitted to CCGI via flat file, are provided in CCGI's Terms and Conditions of Partnership.

#### Requirements for Relevant K-12 SIS Vendors

SIS vendors who contract with LEAs enrolling California public 9th-12th grade students are required to:

- 1. Provide data according to the Spec, including both required and optional fields.
  - a. This will be demonstrated through mapping their product's fields to the elements in the Spec.
  - b. Vendors are expected to add any needed fields to be able to provide both required and optional elements.
- 2. Develop an Application Program Interface (API) to provide data according to the Spec to CCGI.
  - a. Vendors who serve fewer than 10 California public LEAs with fewer than 50,000 9th-12th grade students enrolled in them may apply for a waiver of this requirement, and develop an extract to facilitate data sharing as an alternative.

SIS providers are precluded from passing any cost associated with these statewide enhancements to their products onto the LEAs.

SIS providers are expected to complete both requirements on or before January 1, 2026 to facilitate the requirement that LEAs provide this data to CCGI no later than June 30, 2026.

#### **CSIS Matrix Publication**

Beginning in January 2025, CSIS will publish a Matrix describing each vendor's capability in providing data to CCGI, similarly to its current Matrix describing CALPADS SIS Vendor and Product Capabilities.

All SIS vendors that have contracts with LEAs serving California public 9th-12th grade students must participate in the process to verify their capability. This includes developing and maintaining a mapping document, describing field-level compliance with the Spec, and outlining data submission capacity. All SIS vendors are expected to develop APIs, though vendors whose SIS products serve fewer than 10 California public LEAs with fewer than 50,000 9th-12th grade students enrolled in them may seek an annual waiver from CCGI to use an extract only, as permitted by EDC § 49083.5 (b)(4).

## Introduction

Cal Ed Code § 60900 (f)(3) requires local educational agencies (LEAs) serving 9-12th grade students in California to: "Submit grades 9-12, inclusive, pupil transcript information to the California College Guidance Initiative, as authorized pursuant to Section 60900.5, according to processes and timelines established by the California College Guidance Initiative."

Cal. Ed. Code § 60900.5 (g)(8) requires the California College Guidance Initiative (CCGI) to provide: "Transcripts processed in near real time with the California Community Colleges, the California State University, the University of California, and the Student Aid Commission, using an application programming interface."

To facilitate this work, CCGI has developed the California High School Transcript and Student Record Portability Standard, known hereafter as "the Standard." The Standard provides guidance for California public high school transcripts and details the required and optional data elements for Student Record Portability. These elements include, but are not limited to, those which would be contained in a traditional paper transcript. There is no expectation that paper transcript elements be adjusted to match the Standard, as the Standard is intended for electronic data exchange.

Effective summer 2024, Cal. Ed. Code § 49083.5 requires CSIS to track and share online a list of SIS vendors serving California public high schools, including a designation indicating whether or not they have a built in API for transmission of data to CCGI and are able to provide data in accordance with the California High School Transcript Portability Standard and the associated Data Specifications. In accordance with this Ed. Code CCGI developed and will maintain this document, the **CCGI SIS Vendors Capabilities Procedure,** in order to assist CSIS in the tracking and publishing of this information.

SIS vendors who contract with LEAs enrolling California public 9th-12th grade students are required to:

- 1. Provide data according to the Spec, including both required and optional fields.
  - a. This will be demonstrated through mapping their product's fields to the elements in the Spec.
  - b. Vendors are expected to add any needed fields to be able to provide both required and optional elements.
- Develop an Application Program Interface (API) to provide data according to the Spec to CCGI.

a. Vendors who serve fewer than 10 California public LEAs with fewer than 50,000 9th-12th grade students enrolled in them may apply for a waiver of this requirement, and develop an extract to facilitate data sharing as an alternative.

SIS providers are precluded from passing any cost associated with these statewide enhancements to their products onto the LEAs.

SIS providers are expected to complete both requirements on or before January 1, 2026 to facilitate the requirement that LEAs provide this data to CCGI no later than June 30, 2026.

# **Data Specifications**

This V1 Vendor Capabilities Procedure references the <u>Data Specification</u> related to the <u>California High School Transcript and Student Record Portability Standard</u> and Data Element Templates that are broken into five components:

The <u>Data Specification</u> is intended for electronic data transmission via an API established between K12 SIS vendors and CCGI and includes Student, Course, Test and Graduation data. Course catalog data should also be included.

Alternatively, the data elements linked below, which outline how data may be submitted to CCGI via flat file.

Student Data Elements
Course Data Elements
Test Data Elements
Graduation Elements
Course Catalog Elements

Vendors are expected to provide fields which map to both the required and optional elements.

### **Procedure**

This document describes both the procedures for the initial inclusion in the CCGI Vendor and Product Capabilities Matrix, hereafter known as "the Matrix," and the procedures for maintaining inclusion over time.

Inclusion in the Matrix is broken into five categories which will be tracked on the **CCGI SIS Vendor and Product Capabilities Matrix** document published by CSIS. Individual data element compliance will be documented in the **CCGI SIS Vendor Data Specification Mapping V1**.

- Compliance with Required Data Elements
- Compliance with Optional Data Elements that Impact CSU/UC Eligibility Tools noted below:
  - LOTE Cert Student Data Element
  - CourseInstitutionName Course Data Element
  - DualEnrollmentIndicator Course Data Element
  - CourseCurriculumTerm Course Data Element
- Compliance will Additional Optional Data Elements
- Compliance with API
  - Required for all SIS vendors serving 10 or more California public LEAs and, for those serving 9 or fewer LEAs with more than 50,000 9th-12th grade students enrolled in them

or

- File Extract Requirements
  - File Extract Compliance has been made available for vendors in the below categories and requires a CCGI API Compliance Waiver:
    - Serving fewer than 10 California public LEAs with fewer than 50,000 9th-12th grade students enrolled in them
    - Vendors not required to comply with the API requirement but wish to develop an Extract

# **API Requirements**

Each vendor will host a secure API and provide CCGI access to its endpoint. Each vendor will manage a process by which the contracting LEA consents to this data exchange. The payload is defined in the CCGI SIS Vendor API Requirements, with an established mechanism to omit data sharing for those students who have followed the LEAs process to opt out as required by FERPA. CCGI's pull will utilize the GET method to retrieve data from the endpoint. This is a read-only method. Each vendor will support their contracting LEA to provide a school-specific configuration file (or other mechanism) to assist in necessary data translations. CCGI will provide an SIS vendor API Requirements document to outline its use more fully for vendors ready to begin the development process.

#### **Initial Verification and Inclusion**

All SIS vendors that have contracts with LEAs serving California public 9-12 grade students must complete the verification process.

#### In this step the vendor will:

- Review the Data Specifications listed in this procedure
- Contact CCGI at <u>dataservices@californiacolleges.edu</u> with any questions regarding the data elements
- Make changes necessary to bring the SIS into compliance with CCGI requirements
- Document internal field mapping to CCGI data specifications in
   CCGI SIS Vendor Data Specification Mapping and submit to CCGI
- Work with CCGI for API technical set up requirements
- Identify an LEA currently in Partnered status with CCGI to participate in testing data submission
  - LEA must be able to submit all required data elements via API
     OR
    - LEA must be able to submit all required data elements and field headers via File Extract (\*\*only with an approved CCGI API Compliance Waiver)

## In this step CCGI will:

- Document SIS vendor information
- Respond to any questions the vendor may have regarding the data specifications
- Provide SIS vendor with CCGI SIS Vendor Data Specification
   Mapping
- Work with vendor for API technical set up requirements or File Extract with approved CCGI API Compliance Waiver
- Work with the Partnered LEA identified by the vendor for testing
- Provide feedback regarding variances during testing
- Add the vendor to the CCGI SIS Vendor and Product Capabilities
   Matrix accordingly

# Requesting a CCGI API Compliance Waiver


SIS vendors serving fewer than 10 California public LEAs with fewer than 50,000 9th-12th grade students enrolled in them may apply for a CCGI API Compliance Waiver. The waiver allows for a vendor to develop a process for LEAs to produce Flat File Extracts rather than an API to provide minimally required data elements to CCGI. Waivers will be reviewed and approved/denied by the Data Services team at CCGI. Vendors with an approved waiver will be reflected as "NA" in the API Compliance section of the Matrix.

## In this step the vendor will:

- Review the CCGI API Compliance Waiver Application
- Contact CCGI at <a href="mailto:dataservices@californiacolleges.edu">dataservices@californiacolleges.edu</a> with any questions
- Complete and submit the **CCGI API Compliance Waiver Application** to the Data Services email <u>dataservices@californiacolleges.edu</u>.

#### In this step the CCGI will:

- Review the CCGI API Compliance Waiver Application
- Respond to any questions the vendor may have
- Approve/deny CCGI API Compliance Waiver Application



SIS vendors included on the Matrix must maintain compliance with CCGI requirements and SIS Vendor Mapping documentation, additionally, vendors must submit a current list of LEAs served and enrollment in those LEAs annually. CCGI is responsible for ensuring timely notification of specification changes to allow SIS vendors to maintain compliance.

#### Re-Verification

When a *major* revision to the **CCGI Data Specifications** occurs, vendors must repeat the process to determine if their product should continue to be included in the Matrix. CCGI is responsible for timely notification of major specification changes which will require re-verification. Major specification changes resulting in a recertification requirement will be reflected in a **CCGI SIS Vendor Capabilities Procedure** version update.

# CCGI API Compliance Waiver Application Procedure

California College Guidance Initiative (CCGI)

CCGI API Compliance Waiver Application V1

October 2024

### **Procedure**

The CCGI API Compliance Waiver Application should be completed by any SIS vendor serving fewer than 10 California public LEAs with fewer than 50,000 9th-12th grade students enrolled wishing to be granted a waiver for the development of an API. Vendors applying for this waiver acknowledge that the waiver, if granted, only waives the requirement of the development of an API and does not waive the requirement of vendors to add the data elements described in the Data Element Templates and develop an Extract for the purpose of assisting LEAs in providing the data elements to CCGI.

#### **Initial CCGI API Compliance Waiver Application**

Vendors applying for an API Compliance Waiver must complete the Waiver Application and submit it to the Data Services team at California College Guidance Initiative (CCGI) by email at <a href="mailto:dataservices@californiacolleges.edu">dataservices@californiacolleges.edu</a>.

#### In this step the vendor will:

- Complete and submit the API Compliance Waiver Application to CGGI
- Submit a current list of LEAs served and enrollment in those LEAs annually, demonstrating their continued eligibility of serving fewer than 10 California public LEAs with fewer than 50,000 9th-12th grade students enrolled in them

# In this step the CCGI will:

- CCGI will respond to the Application Request within 30 days of the initial request to inform the vendor of application status
- CCGI will update the Matrix to reflect "NA" in the API Compliance section of the Matrix in the next available iteration of the Matrix, expected but not guaranteed to be within 30 days of approving the CCGI Compliance Waiver

# **Renewal of CCGI API Compliance Waiver Application**

By August 1 each fall, vendors must renew their Application status by self-reporting, to CCGI, a current list of LEAs served and enrollment in those LEAs, demonstrating their continued eligibility of serving fewer than 10 California public LEAs with fewer than 50,000 9th-12th grade students enrolled in them.

Vendors failing to update their waiver application requirements by August 1st will be reverted to a "No" status in the API Compliance section of the Matrix and will

be required to submit a new API Compliance Waiver application if they wish to reinstate their waiver status.

## **Application Denial**

CCGI is required to notify vendors of application denial within 30 days of receipt of the application. Vendors who wish to petition the denial of their API Compliance Waiver Application must do so by submitting a letter of appeal to the CCGI Data Services Team at <a href="mailto:dataservices@californiacolleges.edu">dataservices@californiacolleges.edu</a> within 30 days of the date of denial.
