About CaliforniaColleges.edu

CaliforniaColleges.edu, the State of California's official college and career planning platform, is managed by the California College Guidance Initiative (CCGI). Founded in 2013, CCGI is an equity-focused nonprofit that seeks to:

- Ensure that all California high school seniors graduate with a plan for life after high school.
- Simplify and streamline college and financial application processes.
- Provide K-12 educators and postsecondary systems with the data they need to make accurate and timely decisions that impact student success.



What We Are Trying to Solve

Students and parents, particularly those in underserved communities, face numerous hurdles throughout the journey from K-12 to postsecondary education. These include:



California-specific college and financial aid processes are often **complex**, especially for students from underserved communities.



Counselor-to-student ratio is **1:509-more than twice** the recommended ratio of 1:250, making it difficult to provide individualized attention to student needs.



Persistent equity gaps in access to information about college and career, "a-g" completion rates, college matriculation, and financial aid uptake.





Enrollment at California State Universities (CSUs) and California Community Colleges (CCCs) has **declined** due to the COVID-19 pandemic.¹ California "ranks **number one across the nation in unused aid**, leaving the most Pell Grant dollars on the table due in part to **low financial aid application completions**."²

Making it easier for students and educators to track "a-g" completion.
