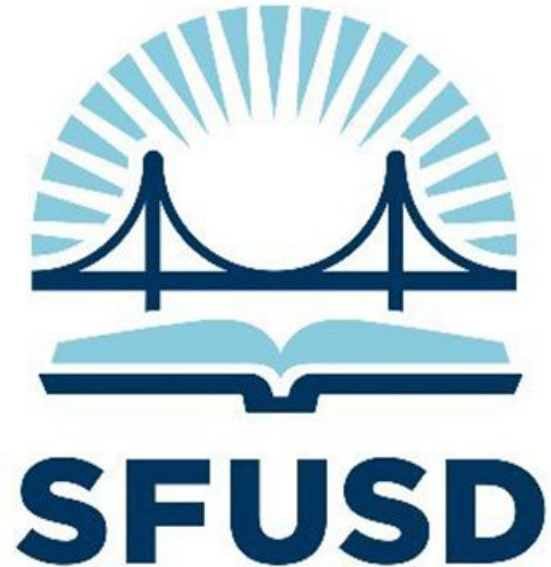

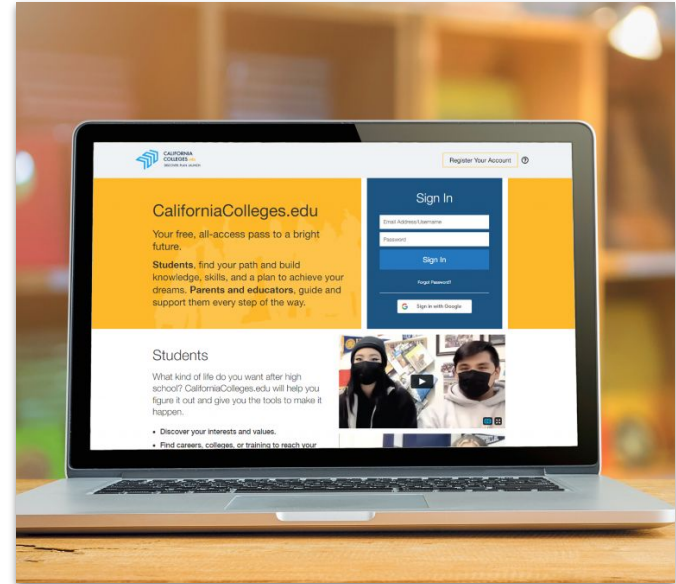




What We Do

What about Dual Enrollment?

- ▶ Dual Enrollment (DE) is a method that students can use to meet A-G requirements, but these courses cannot be verified against the CMP.
- ▶ DE will surface in Yellow as “Requires Review” to indicate to the student that **action is required** in their CSU and UC applications.
- ▶ It is by design that DE courses cannot be imported into the high school coursework section of Cal State Apply and the UC Application:
 - College courses must be entered into the College sections of both applications, which are programmed to recognize one semester of College coursework as fulfilling a full year of A-G.

Application for Admission to College

Before applying to college you must first have an OpenCCC account.

The OpenCCC single sign-in account allows you to access the online services of the California Community Colleges.

OpenCCC is a service of the California Community Colleges Chancellor's Office. The information in your account is kept private and secure.

- ▶ **Sign In** with your CCCApply account **OR Create an Account** (first-time application launches).



California Community College Application Process

When students in CCGI partner districts launch CCCApply from within CaliforniaColleges.edu, two important things also happen:

- ▶ Their **Statewide Student ID (SSID)** is matched to their **California Community College (CCC) ID**, creating a **hard match** across systems.
- ▶ CCCs that utilize the the **Multiple Measures Placement Service** will get English and Math **placement recommendations** and GPA based on pre-verified transcript data.
- ▶ Once an application is submitted, the **date of submission** is recorded in the **College Applications** section of **My College Plan**.
 - CCCApply application status is generally updated within **30 minutes**.

There are lots of great reasons to attend a California Community College (CCC). A CCC may be the best fit for you if:

- You need an **associate degree or certificate** for the career you want.
- You want to **start your career sooner**. Associate degree programs usually take two years. Certificate programs take even less time.
- You want to **prepare to transfer** to a four-year college.
- You want to **spend less money** on college tuition. CCCs have the lowest fees in the nation.
- You want to **stay close to home**. With 115 campuses across California, there is probably a CCC close to you.
- You need **flexible classes** in the evening, on weekends, or online so you can fit college into your life.
- You want to **get a head start on earning college credit** while you're still in high school.

Requirements

To attend a CCC, all you have to do is fill out an application and pay any required fees. You don't have to complete A-G requirements or take any special classes.

You can start at a CCC and transfer to a CSU, UC, or independent college after two years. Complete one of the programs below at your CCC to secure your spot.
