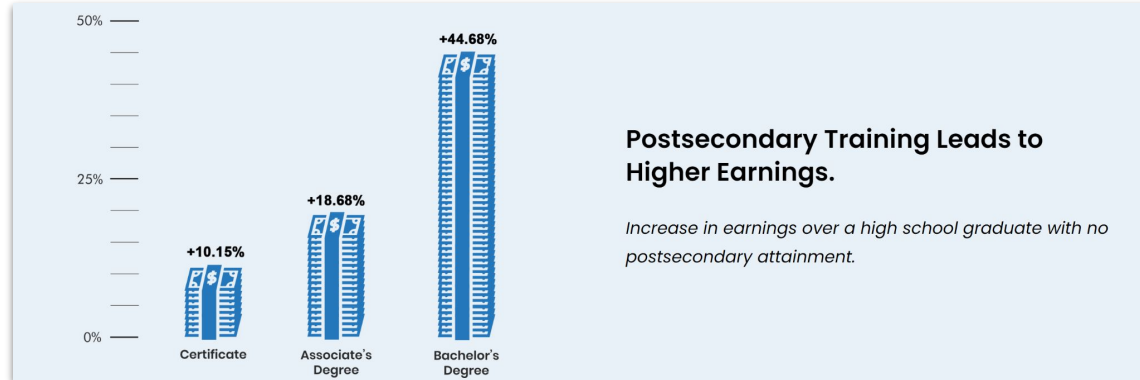




Differential Access & Outcomes

While we know that post-secondary education results in higher lifetime earning, we also know that:

- ▶ Students from higher-income backgrounds are more than twice as likely to earn a bachelor's degree than their lower-income peers.
- ▶ The vast majority of low-income Latinx and African-American students never attend a 4-year college.

Our Three Big Goals

CaliforniaColleges.edu is a 6th-12th grade college and career guidance platform and data infrastructure which can be used to close equity gaps by:

1. **Systematizing college and career knowledge development** and access to high quality information for all 6-12th public school students.
2. **Streamlining the college and financial aid application process** for students and the educators supporting them.
3. **Providing educators with the data they need to:**
 - a. Monitor student progress and provide targeted interventions to move the needle on college and career readiness, eligibility, application and enrollment rates.
 - b. Inform high stakes decisions about admissions, placement, advising, financial aid, and supportive services as students transition to college.



Ed Trust West – The Equity 8

Each year, the Ed Trust-West analyzes proposals for the state budget and new legislation and identifies the top eight opportunities to advance educational equity and justice:

- ▶ In 2024, the Equity 8 included proposed investments in the California College Guidance Initiative to extend access to all 6-12th grade public school students in California.



Budget Proposal (Governor Newsom): \$5 Million for the California College Guidance Initiative

College admission and financial aid requirements are complex, and applying for either can be intimidating. The California College Guidance Initiative (CCGI) helps students and families by providing data-driven tools and infrastructure with student-focused curricula to help students move seamlessly from high school to college and/or a career. An increase of \$5 million in ongoing funding will extend access to this platform to all 6th-12th grade students in California. This investment will help students and families understand their options, research job markets, submit college applications, and apply for financial aid. This platform will also give high school counselors access to information they need to provide students with one-on-one support in their college application process. This funding will be a big boost to college and career readiness.

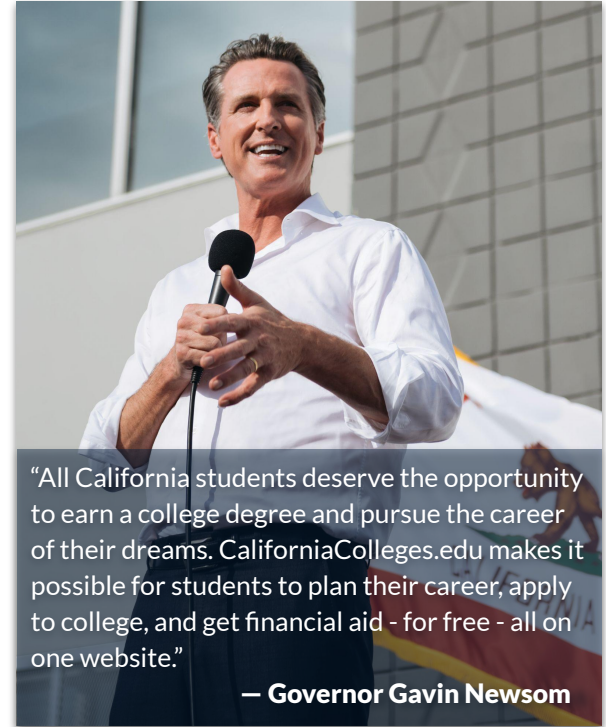
UPDATE: This is a win! The governor and the legislature approved an increase of \$2 million for the California College Guidance Initiative (CCGI) in the final 2024-2025 state budget. This is enough to accomplish the needed expansion of the CCGI.



Why has California Invested in a Common Platform?

Key Facts:

- ▶ **80%** of K-12 students in California **stay in-state** for training and education after high school.
- ▶ **56%** of high school seniors **did not meet A-G** requirements for CSU or UC admission in 2023.
- ▶ Students have to navigate **California-specific processes** and therefore need **California-centric tools and resources**.
- ▶ **Districts** likewise need **tools to support implementation** of policies and investments aimed at **increasing student success**.





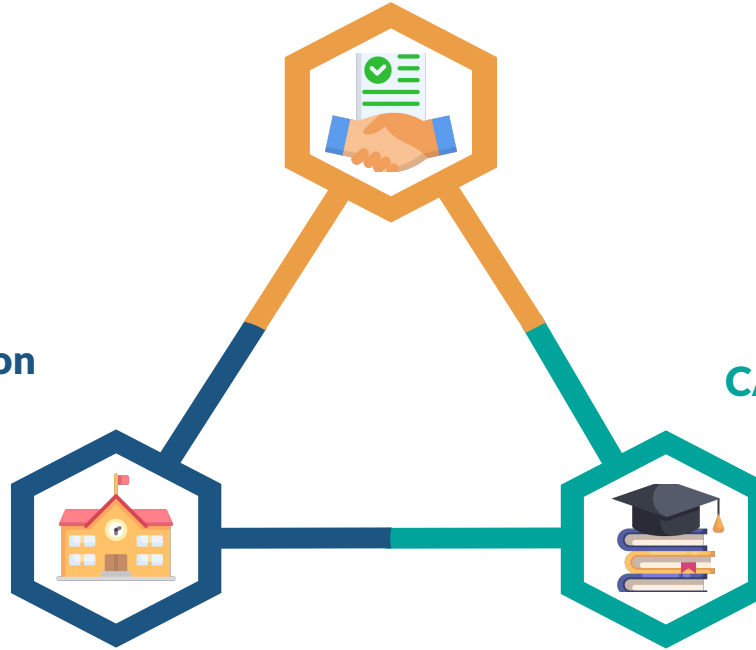

Our Role in the Cradle-to-Career Data System

CaliforniaColleges.edu is a crucial component of the C2C Data System tools

In 2021, the enactment of AB 132 outlined specific steps in order to implement the Cradle-to-Career (C2C) Data System and realize its objectives, including:

- ▶ Making CaliforniaColleges.edu tools and services **free to all California school districts serving 6-12th grade students**, with a goal of full participation by 2026.
- ▶ Designating CaliforniaColleges.edu as the **preferred starting point for all applications to California public colleges (CCC, CSU, UC), FAFSA, and CADAA.**

Scaling CCGI

Significant work has been done since 2021 to bring CaliforniaColleges.edu to all 6-12th grade public school students in California:

- ▶ **Fall 2024** : A data-sharing agreement executed between CCGI and the California Department of Education (CDE) leverages Calpads data to bring at least the **Basic account** features of CaliforniaColleges.edu to all 6th-12th grade public school students.
- ▶ California Education Code 60900(f)(3) now requires that all LEAs that enroll 9-12 grade students enter into a data sharing agreement with CCGI by **January 2026** in order to bring **Transcript-informed accounts** to students.



Basic Accounts

Students with Basic Accounts are able to use many of the tools on CaliforniaColleges.edu:

- ▶ Students with Basic accounts have access to:
 - Career Assessments & Exploration
 - College & Major Search tools
 - Financial Aid Lessons
 - Ability to launch applications to California's systems
- ▶ Students with Basic accounts cannot:
 - View their progress towards meeting CSU or UC eligibility requirements
 - Import verified course data into their applications.





Statutory Requirements

Under Ed Code Section 60900.5, the California College Guidance Initiative (CCGI) is charged with:

1. Developing college, career and financial aid lessons and tools, that facilitate college and career planning for students in Grades 6-12, families and the educators serving them.
2. **Ensuring all 9th-12th grade students have transcript-informed accounts on CaliforniaColleges.edu.**
3. Pre-populating applications to the CCC, CSU and UC systems with students' SSID, course and grade information.
4. Providing final transcripts to the public higher education systems and transcript level data to CSAC.



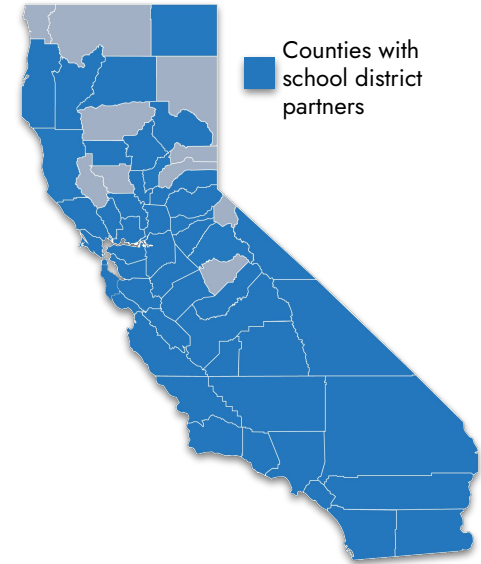
Transcript-Informed Accounts

Partner Districts have a formal data-sharing agreement (MOU) with CCGI in order to bring their high school transcript data to CaliforniaColleges.edu.

- ▶ More than **70% of California's high school** students are enrolled in a school district that has already partnered with CCGI.
- ▶ Our Partner Districts include more than **265 school districts** that serve more than **1.3 million 9th-12th grade students** in California.

Partner Districts

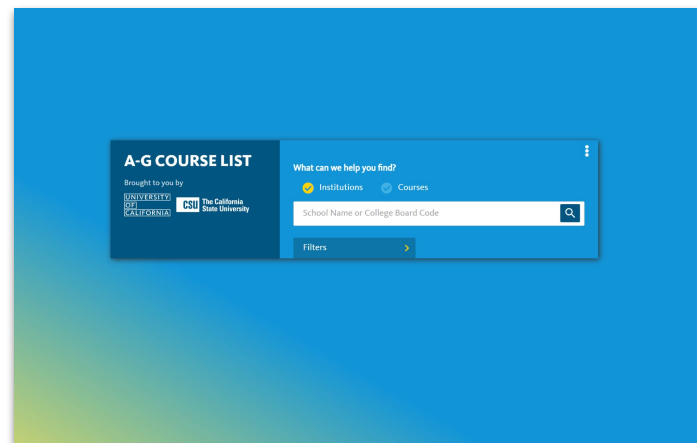
Partnership with CCGI allows for full access to the tools of CaliforniaColleges.edu.

- ▶ **Transcript-Informed Accounts for students,** which include:
 - **California Community Colleges (CCC) Tool** which helps students to identify the 5 CCCs closest to their high school and to learn more about program options.
 - **CSU and UC Eligibility Tools** that allow students to see their progress towards meeting the minimum requirements for admission to a CSU and UC.
 - The ability to **import verified transcript data** to their Cal State Apply application and UC Application.
- ▶ **Enhanced Educator Reporting** to support ongoing progress monitoring and intervention.
- ▶ **A-G Alignment Support** for districts to ensure that students get correct A-G credit for high school courses and grades in their college applications.

A-G Alignment Support

The Course Management Portal (CMP) is where all California districts and/or their schools manage their public-facing “A-G Course List”

- ▶ The approved course list from the CMP is what determines which courses fulfill an A-G subject area for the purpose of CSU and UC admissions processes.
- ▶ CaliforniaColleges.edu uses the official CMP course list for each school to **verify the transcript data** shared by the district/LEA from its Student Information System (SIS).
- ▶ When course information contained in the CMP does not match how course records are recorded in a district's SIS and on student's transcripts, it may impact CSU and UC admissions eligibility.





Technical Assistance

CCGI provides technical assistance help to LEAs to ensure that courses indicated as fulfilling A-G requirements match the Course Management Portal.

- ▶ California Education Code 60900(g) requires that LEAs maintain at least a 90% rate of alignment between A-G coursework, as listed in the local SIS, and how those courses are registered in the UC Course Management Portal A-G course list.
- ▶ CCGI has a dedicated Technical Assistance team to support districts in improving their CMP match rate.
- ▶ CaliforniaColleges.edu reporting features help educators in partner districts to identify and resolve issues with their CMP list that may impact eligibility for students:
 - Academic Report: **Which district courses are flagged as A-G but do not match against the CMP?**

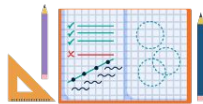

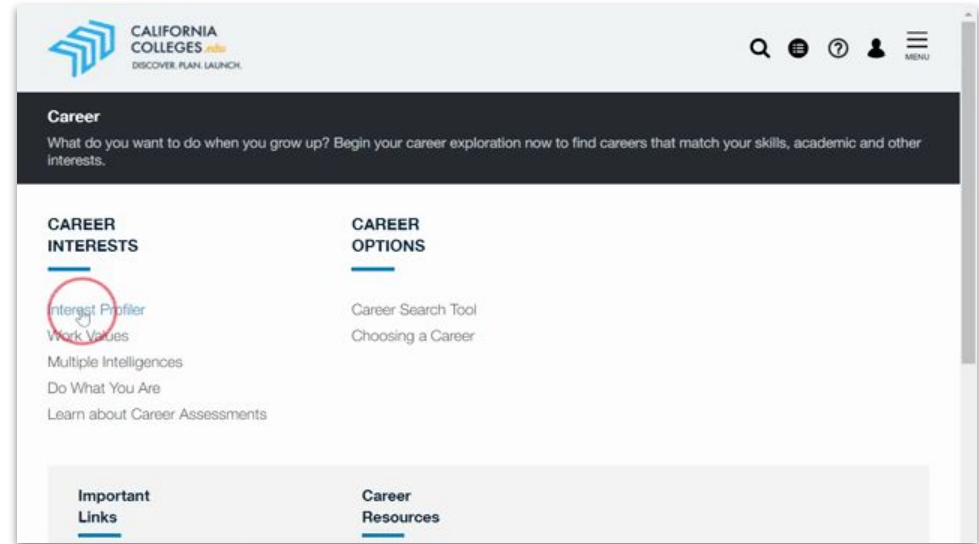


Career Assessments

There are lots of great reasons to attend a California Community College (CCC). A CCC may be the best fit for you if:

- You need an **associate degree or certificate** for the career you want.
- You want to **start your career sooner**. Associate degree programs usually take two years. Certificate programs take even less time.
- You want to **prepare to transfer** to a four-year college.
- You want to **spend less money** on college tuition. CCCs have the lowest fees in the nation.
- You want to **stay close to home**. With 115 campuses across California, there is probably a CCC close to you.
- You need **flexible classes** in the evening, on weekends, or online so you can fit college into your life.
- You want to **get a head start on earning college credit** while you're still in high school.

Requirements

To attend a CCC, all you have to do is fill out an application and pay any required fees. You don't have to complete A-G requirements or take any special classes.

Within a MTSS Framework

CaliforniaColleges.edu can be leveraged to support Tier 1 learning for all students, while increasing efficiency and ability for educators to strategically intervene with those who need support at Tier 2 and 3.



Tier 3 – Intensive Interventions

Efficiencies at Tier 1 and 2, free time for educators to provide 1:1 support.

Tier 2 – Targeted Interventions

Educator tools and reports on CaliforniaColleges.edu allow for targeted interventions with individuals or groups of students.

Tier 1 – Universal Interventions

CaliforniaColleges.edu is the state's official college and career planning platform, designed for all 6th-12th grade students.



Implementing Equity-Focused State Policies

Districts can use the data and reporting tools on CaliforniaColleges.edu to support successful implementation of equity-focused state policies.





What about Dual Enrollment?

- ▶ Dual Enrollment (DE) refers to college courses taken while in high school. They do not appear on the high school “A-G Lists” in the CMP, as these are college courses.
- ▶ DE courses can be used to meet CSU and UC eligibility requirements.
- ▶ DE courses must be manually entered into college applications, but students and educators may be unfamiliar with which college courses are recognized as meeting which A-G requirements.
- ▶ Our goal is for students DE courses to be included on students records in CaliforniaColleges.edu, in order to:
 - More accurately represent CSU/UC Eligibility
 - Integrate college coursework into the application integrations with public colleges
 - Deliver a unified final transcript at the point of high school graduation



New Ed Code (Summer 2024)

The following subsections of code is a policy anchor, which establish **CaliforniaColleges.edu** as the future state infrastructure for the work outlined below:

*EDC § 48800(c) A pupil shall receive credit for community college courses that the pupil completes at the level determined appropriate by the governing boards of the school district and community college district. Using available funding apportioned to the community college district pursuant to Section 84750.4, the governing board of the community college district shall report the pupil's completed courses and grades received through eTranscript California, also referred to as "eTranscriptCA," for purposes of enabling the uniform integration of the pupil's completed courses and grades received into the pupil's universal and electronic high school transcript that is housed on the **CaliforniaColleges.edu** platform.*

The implementation timeline for the code section above is not yet determined, but the opportunity and intent is clear.
